**Engineers' Report**- In the absence of Jim Caldwell and/or Mike Knouse, Brian O'Neil filled the engineer's chair.

Managers' Report- Township Manager, Donald Umberger informed Supervisors of the following: 1. Raymond Hoover's request for a change in the Zoning Ordinance allowing temporary housing will have to have a recorded agreement stating the temporary housing will be removed upon death of Raymond Hoover and his wife. 2. Street Dedication for Old South Crossing and Letter of Credit and Speed Limit Ordinance are all in order and ready for Supervisors acceptance and or approval. 3. Servant Oasis Sewage Module is in need of comments from both SAT Planning Board and Lebanon County Planning. Once comments are in SAT will forward the Sewer Planning Module to DEP. 4. SATA is in the process of discussing lowering the RTS Charges and authorization was given to Donald to draft a letter urging the Authority to do so ASAP. 5. SAT has one resident who is delinquent with sewer payments forcing the Township to have SAT Solicitor, Josele Cleary file charges with the Magisterial Justice. 6. Police Negotiations continue between SAT and Cleona and Annville Police Departments. 7. The 2019 Preliminary Budget will be ready for Supervisors to review at next month's meeting.
