Engineers' Report- Jim Caldwell of Rettew Engineering informed Supervisors that the 2021 Road Project Bids have resulted in his recommending accepting New Enterprise Stone & Lime Co, Inc. the low bidder of \$170,978.70 for Paving and Asphalt Maintenance Solutions the low bidder of \$254,049.70 for Surface Treatment. Mr. Caldwell also told Supervisors that his firm has scheduled a MS-4 Preconstruction Meeting for May 13th at 8:30 A.M. for the Bachman Run Restoration Project with property owner's, Robert and Ellen Disantis, Rettew Engineering, Flyway Excavating, Inc. and South Annville Township Representative. Along with the need for a signed Change Order of an additional \$2,825.00 for the Bachman Run Restoration Project. The Killinger Road Paving continues to move at a pace that is a little slower than anticipated because of the limestone soil making paving a bit tricker. JVI has Completed and Satisfied the Township portion of the Killinger Road Paving.

<u>Managers' Report</u>- Township Manager, Donald Umberger informed Supervisors of the following: 1. The Lawn Ambulance is in negotiations for joining with First Aid and Safety Patrol with a meeting scheduled for May 13th. Supervisor Dale Hoover will attend the meeting. 2. A South Annville Township Resident who wishes to remain anonymous wanted the Township to consider Adopting an Ordinance that deals with feral cats.
