Managers' Report- Township Manager, Donald Umberger informed Supervisors of the following: 1. Buckle Up PA Grant Forms are ready for signatures. 2. In the meantime, Supervisors assured Garman Builders that they are first in line for the extra EDU's. 3. Michael Schroeder's request for township support and funds for hiring two interns for 2019 Quittapahilla Watershed Association. 4. A Sidewalk Ordinance will be prepared by South Annville Township Solicitor, Josele Cleary and should be ready for adoption at the April meeting. 5. A request from Farm Land Preservation to defer decisions to North Cornwall Township about a farm property that is ½ in North Cornwall Township and ½ in South Annville Township. The property is owned by Nancy Todd. Both Supervisor Hoover and Supervisor Harrell agreed to the deferring.

Motion by Supervisor Hoover to authorize Township Manager, Donald Umberger to sign the agreement for the PA Buckle Up program once Chief Sutcliffe provides more information; second by Supervisor Harrell. Motion passed 3-0.

Motion by Supervisor Harrell to hire an independent surveying firm to conduct a survey of Reigert's Lane & Mt. Pleasant Road to locate township boundaries lines; second by Supervisor Rhine. Motion passed 3-0.

<u>Citizens/Public Comments</u>- John Kreiser a township resident, informed supervisors that the stones used in winter maintenance is a possible hazard and wanted to know how they will be dealt with. Ed Kreider, road maintenance person told supervisors that he and his employees will get the stones swept up.
