Engineers' Report

Jim Caldwell informed Supervisors that the advertisement of the 537 Plan has been placed in the newspaper and has a 30 day public comment period ending March 2, 2018. The 537 Plan will be considered for adoption at the March 14th meeting. Jim also asked Supervisors to consider a motion allowing Rettew Engineering to put the 2018 Road Project out for bid in order to consider awarding at the March 14th meeting.

Managers' Report

Township Manager, Donald Umberger updated Supervisors on the sewer hook-up process at 744 West Main Street and that the work on the Sunoco Pipeline has resumed. Donald also shared information from Elan City about the computerized Evolis Radar Speed Sign. The Supervisors will look over the material. Manager asked the Supervisors to consider a Resolution accepting the current stipend fee schedule of the Greater Lebanon Refuse Authority. Donald also reported on the status of the excess water in the SA Community Building Basement.

Motion by Supervisor Hoover to authorize Jim Caldwell of Rettew to put the 2018 Road Project out for bid on PennBid for consideration of award at the March 14th meeting; second by Supervisor Harrell. Motion passed 3-0.

Motion by Supervisor Hoover to adopt the Swatara Sojourn Proclamation as presented; second by Supervisor Harrell. Motion passed 3-0.

Citizens/Public Comments- Township resident John Kreiser asked how the overflow of water at the SA Township Community Building will be handled. Township Manager, Donald Umberger responding to the question said that plans for landscaping are in progress.
