Outfalls and BMP inspections will be performed by the end of 2025. Candler's Pointe Phase 3 finalized plans have been reviewed, and Ms. Garner will meet with Candler's Pointe Phase 3 representatives to inspect anything that is within the public right of way.

Manager's Report- Township Manager, Jeanette Henning along with Assistant Township Manager Heather Mesko informed Supervisors of the following: Resident Ed Fogelsanger who is the SAT Greater Lebanon Refuse Authority Representative's term is up and he is seeking approval for another five-year term. Trick or Treat night will be October 31 from 6 PM to 8 PM. The Talview Dairy which is placed in Farmland Preservation is having an open house scheduled for October 15 from 2 PM to 4 PM.
