Motion to accept the Treasurer's Report was made by Supervisor Harrell; second by Supervisor Hoover. Motion passed 3-0.

<u>Engineers' Report</u>- Jim Caldwell of Rettew Engineering informed Supervisors that work on the MS4 Permit has begun. Rettew Engineering will continue to work with DEP's regulations in the first step of getting the property owner's (DiSantis) agreement form signed to begin work on the stream restoration project for Bachman Run. He went on to tell Supervisors that Garman Builders of The Meadows at Bachman Run, Phase II continues to address Engineer's findings as related to one handicapped ramp to bring it to ADA's codes.

Managers' Report- Township Manager, Donald Umberger informed Supervisors of the following: 1. Glenn Reichardt, President of Quitty Rod & Gun Club asked Supervisors to consider putting games of chances on the 2021 vote. 2. Southgate @ Annville requested an additional 40 EDUs. 3. Gordon Waldhausen spoke to Supervisors asking them to look into water run off issues affecting his property on Brandt Road. 4. Jeanette Henning, Administrative Assist, gave a brief presentation on the Spotted Lanternfly. 5. The Pre-Conditional Hearing Meeting for Southgate @ Annville was held September 5th with plans to continue to the next phase of the development project. 6. Issues concerning the Annville/Cleona Resource Officer will be handled between SA Township Solicitor Josele Cleary and the A/C School's Solicitor. 7. A meeting about constructing a pedestrian bridge over the Quitty will take place on September 26th. Representatives from the State, County, Garman Builders, Annville Township and South Annville Township will be in attendance.
