<u>Engineer's Report</u>- Allison Garner of Rettew Engineering informed Supervisors of the following activities for the month: Reviewing plans for Southgate Development and Wynfield, Phase 1A. Looking into the proposed remediation for the Killinger Road discrepancies between DHL and Northpoint. Attended a Preconstruction meeting at Wynfield Development for the proposed water line extension. The extension is scheduled to begin Monday, January 16th. This extension will require a road closure between the hours of 7:30A.M. and 4 P.M., school buses will have access through this closure.

Managers' Report- Township Manager, Jeanette Henning informed Supervisors of the following: The 2023 Road Project which includes 4/10th of a mile on Lake Drive from Mt.
