Minutes of November 2017

Motion to approve the minutes of the Board of Supervisors Meeting for November made by Supervisor Harrell; second by Supervisor Horst; motion passed 3-0.

<u>Treasurers' Report-</u> Twp. Manger presented the financial reports for acceptance which included the following: Invoices paid and pending, Revenues received Treasury report fund totals /financial report. Motion to accept the Treasurer's Report was made by Supervisor Horst; second by Supervisor Harrell; motion passed 3-0.

Engineers' Report

Jim Caldwell reported that the 537 Plan will need to have two clearances submitted because DEP changed the sewer system from low pressure to a gravity system. This change will require more time from DEP resulting in a resubmission of the plan. Jim will prepare a draft for the resubmission for Supervisors to review at the January meeting which allows time for advertising in February so that adoption can take place at the March meeting. Jim also said that Wilson Consulting Group will do a final inspection of the Killinger Road Bridge repair to finalize the repair project. Township Manager, Donald Umberger reminded Supervisors that the cost of the bridge repair will be shared with North Londonderry Township.

Managers' Report

Manager Donald Umberger informed Supervisors that Township Solicitor Josele Cleary will prepare a draft of the Township's Wireless Communication Ordinance for review and possible adoption at the February meeting. He went on to remind all about the January 2, 2018 Organizational Meeting which will start at 7:00 PM in the Community Building. Donald told Supervisors that the Edward Kreider Paving Contract will expire in August of 2018 and he received a flyer from Penn State Health, Milton S. Hershey Medical Center offering a free class called Stop The Bleeding, which deals with an emergency bleeding situation.
