This is a breakdown of some of the incidents that may need some explanation on the police report submitted for the month of March 2017 for public release. Most of the incidents are self-explanatory, this breakdown will explain a little more in depth some of the incidents and also give you information that you may find of interest for yourself and for public safety issues.

**Traffic citations:** During the month of March there were **Three Traffic Enforcement Details** conducted. The first Detail was in the 900-1000 block of Horseshoe Pike, this detail resulted in twenty-two citations issued all speed related. The second Detail was in the 600 block of Louser Road; this resulted in twenty-two citations speed related and one citation for a registration violation. The third Detail was in the 200 block of Mt. Wilson Road and this Detail resulted in eight citations issued all speed related.

**Request to see Officer:** This type of incident is anytime an individual contacts our department for any type of information or concerns that do not fall under one of our reporting criteria.

**Follow up investigations:** This incident is whenever an officer has to conduct a continuing investigation on any report of an incident that requires an investigation.

**House check:** We encourage all Township residents that may be leaving their home for more than a day to inform us. This also includes a situation where a resident may be listed as a relative in an obituary notice for a family member that has died and the viewing and funeral is advertised. For further details please contact us at 717-867-1003.

**Alarm:** South Annville has numerous businesses and residential property that have alarm systems. We do not require any alarms to be registered with the Township. We do ask that all residents please make sure that all notifications with your alarm company are up to date and also have several notifications on your list. We have had numerous times that these are expired and notifications cannot be made. To be able to assist you better, please double check your notifications. **Fraud:** Please be very careful with any telephone calls that you may receive asking for money or any personal information. This time of year there are a lot of phony calls that the callers are stating they are with the IRS. The IRS will only contact you via mail and that is all. Any calls from the IRS should be considered a fraudulent call in an attempt to gain personal information or money from you. Please do not give out any information that is of a personal nature.

**Robbery:** As you may have noticed, there is one incident for this month. This is under investigation and so far the investigation looks like this is an isolated incident and was what we call a targeted incident against a particular person (s).

**Soliciting complaint:** The Township does have a soliciting ordinance and a permit is required to solicit in the Township. The only organizations that are exempt are non-profit organizations like Churches and the Boy/Girl Scouts. Any organization or business that solicits otherwise requires a permit. All permits

are issued by the Police Department of South Annville Township. If a person has another permit that is from another municipality that permit is not valid in South Annville Township. Please call the Office at 717-867-1003 or the Police Dispatcher at 717-272-2054 if you have any doubts about a solicitor that you feel may require a permit.

**Theft:** There were three incidents of items stolen. These were isolated incidents and are not an ongoing problem in any particular area or items. However, we urge any resident to contact the Police if they see anything suspicious, it could end up not being an issue or it could be an actual theft or another crime that may be occurring.
